## Policy for Reserving Pavilions at Pecan Grove Park – Mesa Verde Park – Trinity Hills Park – The Views Park Reservations and Deposits

Park pavilions can be reserved by contacting 512-686-1660 or email request to [help@hayswcid.org](mailto:help@hayswcid.org)

The required deposit amount is based on the number of guests expected at the event.

<u>Number of Guests</u>	<u>Deposit Required</u>
30 or less	\$ 30.00
31 to 50	\$ 50.00
51 to 75	\$ 75.00
76 to a maximum of 100	\$100.00

Deposits will be refunded according to compliance with the Park Rules and the following Pavilion Rules.

### **PAVILION RULES AND REGULATIONS HOURS ARE SUN UP TO SUN DOWN**

1. No vehicles are allowed on Parkland or the Pavilion.
2. If moved, tables must be replaced in their original locations.
3. All trash must be picked up, bagged, and placed in the trash receptacles provided.
4. No loud music or noise that would disturb neighbors is allowed.
5. Other park facilities must be shared with District residents and are not available for reservation.
6. Alcohol is prohibited

The District reserves the right to impose additional restrictions on use as the situation warrants.

# Hays County Water Control and Improvement District

## Park and Greenbelt Rules

**Do not** use glass containers within any district park, parking lots, playing field, playscapes, sidewalks and driveways, trails, or greenbelts.

**Do not** interfere with an Authorized Sign (*remove, knock down, or deface*) **Do**

**not** possess or use illegal drugs.

**Do not** litter, or deposit or dump refuse or trash on District Park property, except for the deposit of litter in containers designated for that purpose;

**Do not** possess or use a firearm

**Do not** bring any animal into a District Park that is dangerous, or fail to keep any animal under control.

**Do not** damage or remove any park property, or any material or equipment except as authorized by the district.

**Do not** engage in disorderly conduct or behavior constituting a breach of the peace, including, but not limited to, fighting, public nudity, public intoxication, profanity or abusive language.

**Do not** use any device, including, but not limited to radios, that results in the emission of sound in excess of 85 decibels when measured at the source.

**Do not** start or maintain fires, except in fire rings or pits provided by the district for that purpose

**Do not** be on District Park property when the park is closed to the public unless engaged in activities permitted or authorized by the district.

**Do not** permit horses or other than Seeing Eye dogs in public buildings or swimming pool areas.

**Do not** use, park, or operate a motorized vehicle in any area other than paved access roads or areas expressly designated as parking areas, unless expressly authorized by the district.

*(Moped, power-driven bicycle, motorcycle, motor scooter, automobile, truck, golf cart, tractor, and all-terrain vehicle)*

**Do not** violate any other Park Rule adopted by the Board of Directors of the

District. **Do not** bring or consume alcoholic beverages

### ***-Enforcement -***

Fine up to \$500.00 for violation of rules
